2. Matters arising

re item 5.3 – Clerk had found full contact details for landowner, and passed these to both Mr Cluley and Mr Barton; however, no action, other than a bit more driving over it, has been taken to improve this surface. The continuation of this bridleway into Cowley parish through a field is already waterlogged and rutted, and it must be a concern that the landowner may decide to attempt to 'improve' the surface here in the same way as the section through the wood. 4. GRCC Housing Needs Survey

Mr. Hutchins of GRCC presented his report on the recent survey. Elkstone is one of the smallest parishes surveyed to date. It has 101 households, and there was a 37% response rate. (The usual response rate is between 20 and 40 %) Half of the respondents had lived in Elkstone for more than 20 years. 4 single people and 2 couples indicated a need for local housing now or in 5 years time, with the single respondents being more likely to require affordable housing.

There was further discussion on the Fosseway Living and Orbit Housing criteria; Clerk to check the Orbit Housing S. 106 agreement.
