6. 3/190 and junctions

Ten assorted letters and e-mails had been received from parishioners.

Mr. Luck reported on the site meeting, EPC with Glos Highways, 4th May.

In summary, nothing can be done about the sight lines at the two junctions, nor the suggested mirror, nor the suggested renewal of red tarmac, nor the suggested rumble strips, nor the suggested lower speed limit.

Glos Highways has undertaken to upgrade the signage, probably by this summer, and will regard this as safety/maintenance work, rather than improvements to be match-funded. The illegal shrubby overgrowth on the verge south of the Ivy Cottage Farm gateway is to be removed.
